2. Purchase of the DRIP OILER shall not be made until after notice of approval by the Lower Loup NRD.
3. Cost-share is \$100.00 as reimbursement toward the Turbine Pump Automatic Oiler and Poly Tank.
4. Purchase of the Automatic Drip Oiler and Tank is to be supported by receipt of payment made.
5. Itemized receipts must show the full description of the oiler and tank size purchased.
6. Claims for payment will not be accepted after the expiration date stated above without prior approval of the District.
7. Claims for payment submitted (but being held subject to compliance with all rules and regulations of the Lower Loup NRD programs) may be held only up to 30 days. After 30 days, the claim for payment may be considered void and the original application cancelled.
8. Cost-share recipient agrees to allow unannounced spot inspection of area listed above by Lower Loup NRD for compliance and certification of installation.
9. Applicant will hold the Lower Loup NRD harmless from all claims in equity and law.

APPLICATION & CERTIFICATION: I understand that I must be in compliance with all rules and regulations of the Lower Loup Natural Resources District's programs, both at the time of application in order to receive approval, and at the time of completion in order to receive payment. I certify that the items I submit for which payment is claimed was furnished under authority of the law and the charges are reasonable, proper, and correct. I further certify that I agree to keep the above turbine pump automatic drip oiler and tank in my possession and use them a minimum of five years after the date payment is received. I understand that if I fail to comply with the above, I must refund the money received from the Lower Loup Natural Resources District.
